#### **Objectives** (summary)

The course aims at introducing students basic concepts of economics, law and relation between both fields. Firstly students are familiarized with basic concepts of microeconomics, demand and supply analysis, theory of consumer and producer. It addresses also more specific issues as: perfect competition, monopoly, uncertainty, risk assessment, theory of game and their approach in legal analysis. The course covers basic concepts including introduction to jurisprudence, constitutional law and both civil and commercial law. The last part of course concerns administrative law and economic analysis of regulation (antitrust, environmental protection).
